House Bills	HB 218 HD1 SD2 CD1 (Act 154)	Relating to the Corrections Population Management Commission	Adds the OHA administrator and a member of the public, who is knowledgeable about issues relating to the criminal justice system and has substantial experience or expertise in traditional Native Hawaiian practices, to the Corrections Population Management Commission. (HB218 CD1)
	HB 546 HD2 SD2 CD1 (Act 268)	Relating to the Hawaii Employer-Union Health Benefits Trust Fund	Establishes the Hawaii Employer-Union Health Benefits Trust Fund (EUTF) Task Force to examine the unfunded liability of the EUTF. Requires the EUTF to establish a separate trust fund for public employer contributions with separate accounts for each public employer. Requires the annual public employer contribution to be equal to the amount determined by an actuary commencing with FY 2018-2019.
	HB 749 HD2 SD2 CD1 (Act 99)	Relating to Workforce Development	Establishes the Hawaii Agriculture Workforce Advisory Board to promote agricultural self-sufficiency in the State. (HB749 CD1)
	HB 877 HD1 SD1 (Act 75)	Relating to the Designees for the Directors of the Departments of Commerce and Consumer Affairs, of Health, of Human Services, and of Labor and Industrial Relations for the Board of Directors of the Hawaii Health Insurance Exchange	Allows the Directors of the Departments of Commerce and Consumer Affairs, Health, Human Services, and Labor and Industrial Relations to delegate voting authority to their designees for a specified meeting or meetings. (SD1)
	HB 941 (Act 4)	Relating to the Natural Area Reserves System Commission	Amends the composition of the Natural Area Reserves System Commission by adding a member possessing a background in Native Hawaiian traditional and customary practices, and removing the Superintendent of Education as a member.
	HB 951 HD1 SD2 CD1 (Act 116)	Relating to the Service of Process	Specifies the persons authorized to serve civil legal process. Mandates the Director of Public Safety to maintain a list of independent civil process servers. Shields the State and the Department of Public Safety from liability arising from the acts of independent civil process servers. Establishes a working group to consider various aspects how process servers should be dealt with in the State. (HB951 CD1)
	HB 1130 HD1 SD1 (Act 278)	Relating to the Hawaii Health Systems Corporation	Makes the five regional chief executive officers on the Hawaii Health Systems Corporation (HHSC) Board, ex-officio, nonvoting members. Adds five regional system board members appointed by the Governor to serve as voting members on the HHSC Board. (SD1)
	HB 1133 SD2 (Act 38)	Relating to Public Land	Repeals Chapter 171C, HRS, relating to the PLDC. Transfers PLDC assets to the DLNR. Deposits funds appropriated to the DLNR pursuant to Act 55, SLH 2011, into the Land Conservation Fund. Deposits proceeds in the Stadium Facilities Special Fund and the School Facilities Special Fund into the General Fund. (SD2)
	HB 1258 HD1 (Act 8)	Relating to Aging	Allows Policy Advisory Board for Elder Affairs to honor a non ex-officio member with an honorary kupuna title; requires Governor to consider honorary title when considering honoree's reappointment; authorizes Governor to reappoint honoree for continued terms over the honoree's lifetime. (HB1258 HD1)

Amends Section 205A-62, HRS, to remove the Department of Education from the list of state agencies with responsibilities relating to marine and coastal zone management. (CD1)
	SB 94 HD2 CD1 (Act 76)	Relating to the Hawaii Interagency Council on Homelessness	Provides for the appointment of a House of Representatives member and a Senate member to serve as alternate members on the Hawaii Interagency Council on Homelessness in the absence of the House and Senate member, respectively. Provides for the appointment of a representative of the Hawaii Public Housing Authority on the Hawaii Interagency Council on Homelessness. (CD1)
	SB 106 SD1 HD1 CD1 (Act 214)	Relating to Aging	Establishes and funds a position for an Alzheimer's Disease and Related Dementia Services coordinator. Appropriates funds for programs and services that support the State's elderly population. Establishes the Task Force on Mobility Management. (CD1)
	SB 326 SD1 HD1 CD1 (Act 106)	Relating to Agriculture	Creates a Good Agricultural Practices Task Force to identify and develop food safety guidelines for locally farmed products. (CD1)
	SB 407 SD1 HD2 CD1 (Act 276)	Relating to Island Burial Councils	Clarifies statutory provisions relating to composition and quorum of Island Burial Councils. (CD1)
	SB 563 SD3 HD2 CD1 (Act 72)	Relating to the University of Hawaii	Amends the form and function of the Candidate Advisory Council for the Board of Regents of the University of Hawaii. Repeals the existing statutory provisions regarding the Regents Candidate Advisory Council. (CD1)
	SB 614 SD1 HD2 CD1 (Act 281)	Relating to Public Works of Art	Requires the Comptroller and the State Foundation on Culture and the Arts to commission permanent works of art to honor the late U.S. Senator Daniel K. Inouye and the late U.S. Representative Patsy T. Mink. Appropriates \$250,000 for each year of the 2013-2015 fiscal biennium. (CD1)
	SB 697 HD1 CD1 (Act 108)	Relating to Aerospace	Extends the terms of members of the Aerospace Advisory Committee from two to four years. (CD1)
	SB 890 SD1 HD1 CD1 (Act 95)	Relating to the Hawaii Labor Relations Board	Authorizes the Governor to appoint an acting member of the Hawaii Labor Relations Board if a regular member is temporarily unable to act due to absence from the state, recusal, or illness. Requires the Governor to first consider persons to serve as acting members from a list of names submitted by employee organizations if the regular member is the representative of management or labor and by public employers if the regular member is the representative of management. Clarifies that an acting member shall be appointed for the case in which the recusal occurred, and that the acting member's appointment shall terminate when the final decision is filed or the case is withdrawn. Requires the Access Hawaii Committee to include the portal manager's financial reports in its annual report to the legislature. (SD1).
	SB 1001 (Act 22)	Relating to the Enhanced 911 Board	Replaces the Comptroller with the Chief Information Officer as a member of the Enhanced 911 Board.
	SB 1036 (Act 23)	Relating to Employees' Retirement System Personnel	Allows the Board of Trustees of the Employees' Retirement System, through its Administrator, to appoint one or more investment officers and changes the title of the "Administrator" of the system to "Executive Director."
	SB 1074 SD2 HD1 CD1 (Act 220)	Relating to Physical Therapy	Regulates physical therapist assistants by limiting the use of certain titles and requiring licensure. Specifies criteria for licensure. Adds a physical therapist assistant to the composition of the Board of Physical Therapy. Appropriates funds out of the compliance resolution fund beginning 7/1/2014. (CD1)
	SB 1087 SD2 HD3 CD1 (Act 211)	Relating to Green Infrastructure	Establishes a regulatory financing structure that authorizes the PUC and DBEDT to provide low-cost loans for green infrastructure equipment to achieve measurable cost savings and Hawaii's clean energy goals. Appropriates funds. Requires a report by DBEDT to the legislature. Requires a report by the Hawaii Green Infrastructure Authority to the Legislature. (CD1)
	SB 1176 SD1 HD2 CD1 (Act 117)	Relating to the Hawaii Paroling Authority	Allows certain members of the panel that nominates members for the Hawaii Paroling Authority to appoint a designee. Requires certain parole hearing information to be made public in a specified time frame. Requires three Paroling Authority panel members for quorum, unless it is determined that a sitting panel member must be recused due to a conflict of interest or illness, then the panel may proceed with two members. (CD1)
	SB 1177 HD1 (Act 66)	Relating to the Reentry Commission	Replaces the Reentry Coordinator with the Director of Public Safety, or the Director's designee, as an ex officio nonvoting member of the Reentry Commission. (SB1177 HD1)
	SB 1191 SD1 HD1 (Act 59)	Relating to Boards of Review	Allows for up to 3 boards of review per taxation district and allows members of one board to be temporarily assigned to another board within the same district for purposes of establishing and maintaining quorum. Eliminates the April 9 deadline for each board to commence public meetings; requires meetings at least once annually. (HD1)
	SB 1214 SD1 HD2 CD1 (Act 285)	Relating to Transportation	Repeals the commission on transportation. Prohibits any person or entity or the police from applying a wheel boot to a motor vehicle located on any public or private street, roadway, or highway, or on any public or private property. (CD1)
	SB 1388 SD2 HD2 CD1 (Act 288)	Relating to the Research Corporation of the University of Hawaii	Amends the composition of the Research Corporation of the University of Hawaii's Board of Directors. Modifies the procurement exemption for certain construction contracts. Removes the University President as the President of the Research Corporation. Caps the Executive Director's salary. (CD1)
